Mrs. O'Banner informed Mayor and Council that she will be going over the Surplus Vehicle Sales and opening those bids. Mrs. O'Banner stated payments must be received tomorrow April 14, 2022, by noon in the form of a money order or a cashier's check. Mrs. O'Banner stated they were for some of the vehicles, and some were the freightliner trucks. We have two 1999 Freightliner, a 2003 Freightliner, a 2008 Ford Explorer, 2008 Chevrolet Impala, a 2008 Dodge Charger, and a 2010 Dodge Charger. The minimum bids for the police vehicles were \$500 and the minimum bid for the Freightliners were \$1,000. Mrs. O'Banner reminded everyone that the town reserves the right to reject all bids. Mrs. O'Banner read the first bid for a 2008 Chevrolet Impala for \$850. The next bid is for a 2008 Ford Explorer a bid of \$800. Mrs. O'Banner read the next bid for the 2008 Chevrolet Impala for \$1350. A bid for a 2008 Ford Explorer was read for \$2125. Mrs. O'Banner read a bid for the 2003 Freightliner for \$1,180. Mrs. O'Banner read a bid for a 1999 Freightliner in the amount of \$1,075 and that is the Freightliner with vin ending in 347. Mrs. O'Banner read another bid for the 2008 Chevrolet Impala for \$600 but went with the highest bid originally submitted by the same person for \$800. Mrs. O'Banner stated for the 2008 Ford Explorer was \$2,125. Mrs. O'Banner stated for the 2008 Chevrolet Impala the highest bid was \$1,350. Mrs. O'Banner stated the highest bid for the 1999 Freightliner with the vin ending in 347 was \$1,075. She stated the highest bid for the 2003 Freightliner vin ending in 911 was in the amount of \$1,180. She stated the highest bidders have until noon on April 14, 2022, to pay by money order or cashier's check. Mrs. O'Banner stated there are some more vehicles left over the plan is to put them back in the newspaper and run them again.

Mrs. O'Banner stated textmygov is something she wanted to bring to Mayor and Council's attention. A while back they were talking about trying to get the siren back on

top of the water tower. She stated we need some type of alert system in the event of an emergency.

Mrs. O'Banner stated she attended a meeting along with Mr. Hamilton along with some other owners for Canfor the sawmill. They will be running water from the town all the way to the sawmill for their fire system.

She stated there was a store there which was a dry cleaner, but this will be different since he will just be selling dry goods. She stated he has spoken with surrounding neighbors as well as the bank. Councilman Al. Green asked was it zoned for businesses and Mrs. O'Banner stated it is. Mayor K. Wiley asked for a motion to approve Retail Store on Clarke Street (Old Dry Cleaner), Owner Mr. David Medina. Mayor K. Wiley recognized Councilman A. Green. The motion was offered by Councilman A. County Car which is a concerned citizens group for the County. She stated they are having a community field day on May 14, 2022 at Wade Hampton Highschool Track Field from 10:00am-3:00pm. The reason for the event is that there is lack of communication possibly between the towns. There should be more open communication and interaction between towns. Ms. Welch invited the town, churches, schools, civic organizations, and small businesses to come as well to represent themselves. There are forms to fill out if you do want to come and attend. If you do not want to have a table there will be food, food trucks, and things for the kids. Ms. Welch stated she just wanted to come and formally extend an invitation. Ms. Welch stated Hampton County Car stands for Hampton County Citizens for Active Restoration and Revitalization.
