C. Community Garden-Jennifer Mungin

Mr. Hamilton stated there is a fire hydrant located near the garden and they can attach an apparatus to the fire hydrant where she can connect straight from there. Mr. Hamilton stated they will add a meter and measure the water use so that it matches the agreement. Mayor K. Wiley asked for a motion to approve helping Ms. Mungin obtain water for the community garden. Mayor K. Wiley recognized Councilman Al. Green. The motion was offered by Councilman Al. Green; with a second by Mayor Pro-Tem T. Solomon. Council voted 5-0 in favor of the motion.

D. New Business- Lucille Care Care & Tire, Frank Blake- Mrs. O'banner informed Mayor and Council that Mr. Frank Blake has a business on MLK Jr. Blvd and he applied for a

business license. Mr. Blake stated he is trying to open an establishment at 223 MLK Jr. Blvd. It will be a tire shop, oil change, and brake shop. He would like to do something for the community. Councilman J. Hadwin stated he believes that building was once used for that and as long as he is within guidelines of the town ordinance and state laws with disposal of tires etc. he is fine with it. Councilman Al. Green stated he agrees with Councilman J. Hadwin. Mayor K. Wiley stated she does not see a problem with it as long as there is proper disposal of the tires after rotations and such. Councilwoman D. Bolden asked Mr. Frank Blake what would his disposal be of the tires. Mr. Frank Blake stated the proper disposal of the tires would be to haul them away to the landfill. Mrs. O'banner advised Mr. Blake to check with the business license personnel to ensure he has all needed files.

Mayor Exited Executive Session and Entered Regular Session at 8:19 p.m.



Adjourn


