# Hampton School District Superintendent, Dr. Ronald Wilcox - Hampton School District Building Program and Bond Referendum.

Dr. Wilcox stated the board has decided to build a new high school between Estill and Hampton and the property has already been purchased. Dr. Wilcox stated, they plan to merge the two high schools together next year and once that is completed, they will begin renovating Estill High School for an elementary school. He stated they will close Estill Elementary and move them in with the Middle School so they will have a K-8 school in Estill and the High School students will be included with the new complex. Dr. Wilcox stated they have \$52 million but will

need more than \$52 million dollars to build the new school they were told they would need around \$70-80 million. The bonding individual stated they could possibly borrow up to 25 million dollars without increasing taxes, if they can add the \$25 million to the \$52 million they would have enough to build the new complex. Dr. Wilcox stated they will have to go through the referendum route because they are only able to get \$4.8 million. The referendum route requires them to rely on the voters and ask them the question, would they give the board permission to borrow \$25 million to build the new complex that they wish to build.

Mrs. Jacqueline Hopkins stated she pulled a sample ballot to see how it would look. Ms. Hopkins stated there are three questions on the ballot and only one has to do with the question that Mr. Wilcox asked, which is the third question on the ballot. Ms. Hopkins stated early voting will start the Monday after the 4th Sunday, which is October 24, 2022. Ms. Hopkins stated you can also vote on Saturdays as well from 8:30 AM-6:00 PM.

Dr. Wilcox stated asking for a referendum is not unusual and has been done in the past.
