**Public Works, Water & Wastewater Report- Mr. Capers-** Taken as info only. Councilwoman D. Bolden asked for an extra trash can at Karl Bowers Park.

Administration Report & Safety and Recreation- Ms. Cooks- Taken as info only.

- i. O.A. Present Containing Luxury Ms. Cooks stated the container has arrived and showings will be Monday, Wednesday, and Friday 9:00 AM 2:00 PM and they will need to call in advance.
- ii. Family Fun Day Ms. Cooks stated Family Fun Day is scheduled for July 8, 2023 it begins at 10:00 AM for the Car Show and it is an all-day event. There are various activities going on where citizens can sign up online and citizens are encouraged to bring their family and friends.
- **iii. Fall Festival -** Ms. Cooks stated there is funding in the budget set aside specifically for the Fall Festival.
- **iv. Beautification Committee -** Ms. Cooks stated the Beautification Committee is doing a wonderful job.
- v. Maxine Bostic Property no comment.
- vi. Grants Update Ms. Cooks stated a grant award was received for Ballistic Vests for the Law Enforcement Team. Ms. Cooks stated the projected location of the Law Enforcement Center is waiting the decision of Council and she will present the options again. Ms. Cooks stated she has presented the concept papers for the Town of Estill and the Town of Hampton or any other local businesses for light upgrades from the Department of Energy. The full application is due in less than two months. The next phase of it is two grants that are from the USDA for individual businesses to help retrofit for heating, air windows, doors, and, also lighting as well. The concept paper is about 20 pages long.
- vii. Brown Water Update Ms. Cooks stated it is an issue that will be discussed in Executive Session to try some options that may work.
- viii. Agreement Between Federal Correctional Institution, Estill, SC Has requested to utilize the Bull Durham to be housed as a shelter to get back and forth easily if something happens. They are asking the Town of Estill to help provide this facility.
- ix. Marsha Robinson Building Usage Ms. Cooks stated Marsha Robinson would like to start an After School program when she realized children were in

need of more knowledge after Covid-19. She would like to utilize the dentist office located at Catherine Ave.

- x. Holiday Compensation Ms. Cooks stated she and Mrs. O'Banner were trying to update the policy and procedure books for compensation for holiday time for Law Enforcement Officers. Law Enforcement are working on the Holiday and do not have the option to get off. Ms. Cooks stated Law Enforcement should receive compensation for holiday time worked.
- xi. Barn Dominium Ms. Cooks stated Mr. Braun is interested in moving to the Town of Estill from Bluffton, SC. He is interested in building a barn dominium and she has photos of how he intends for it to look. Ms. Cooks stated we will have to look at the comprehensive plan regarding zoning and it is due to be updated.
- **xii. Update Comprehensive Plan/Zoning Plan -** Councilwoman B. Bolden asked, when the comprehensive planning and zoning take place, will they be looking at other areas to be zoned as well since most of the areas are general residential. Ms. Cooks stated that they will look at other areas as well.

Ms. Cooks stated we can isolate them and just use one side. Mayor K. Wiley recognized Councilwoman D. Bolden. The motion was offered by Councilwoman D. Bolden; with a second by Councilman J. Hadwin. Council voted 5-0 in favor of the motion.

#### L. Public Comment

Jacqueline Hopkins - Directed her comments to Council stating if they can be given the proposed budget ahead of time so they can go over the budget and ask questions. Ms. Hopkins informed Chief Solomon she is glad to have him here in the Town. She stated she is glad to hear the starting salary is good to be able to obtain quality police officers in the town. Ms. Hopkins stated two of the shootings happened in the neighborhood where she lives. She also stated one happened near a family members home. Ms. Hopkins also stated they want to be safe in their homes.

**Eric Grimes** - Directed his comments to Council by stating a lot of positive things are happening within the town. Specifically in reference to Family Fun Day that is coming up and the Car Show. He stated he sent a lot of notifications out to a lot of car folks in the area. The Beaufort Car and Truck Club will be attending, Carolina Dreamers of Bluffton, Dixieland Cruisers, and the Savannah Mustang Club. He stated what is cool about the Savannah Mustang Club is the President of the club lives in Estill. He stated it is an event that he plans to be involved with year after year. He stated he will be making a \$1,000 donation to Family Fun Day.

Annie Ruth Griffin - Directed her comments to Council and mentioned she was not there when water rates were discussed and would like to know what was discussed. Mayor K. Wiley directed the question to Ms. Cooks. Ms. Cooks stated that is what has been proposed to Council to increase it roughly around \$4.00. One of the biggest reasons is because of the Federal prison. The Federal prison was one of the big water clients. There has been a decrease in population since the 2020 Tornado that swept through Estill and took out about \$200,000 out of the budget for water. Ms. Cooks stated we have been thus far supporting the water bond with American Rescue Plan FEMA funding. Ms. Cooks stated that funding is going to run out and if that funding runs out, we will not have the money to pay for the bond that was taken out to get the water. Ms. Cooks stated that is what the increase is for so that we do not default on the bond that was taken out.
