Ms. Cooks mentioned they are finishing up some grants for the citizens and they are waiting for final approval on the concept payments. Ms. Cooks stated they applied for a grant for the Town Hall building as well as partnering with the Town of Hampton. She mentioned partnering with the Town of Hampton for the retrofitting of their lighting systems. Ms. Cooks stated code enforcement will be on the grounds every Thursday and it is official that it is included in the existing contract. A lot of work was put into Project Green Spark. Councilman Green asked is the inspection firm doing just new builds or are they doing renovations as well? Ms. Cooks stated they are doing everything in terms of inspections except those things that may not have been completed by the County.

i. Update on Elementary School Purchase

G. Public Comment

Eric Grimes - Directed his comments to Council. Mr. Grimes thanked Councilman A. Green, Councilman J. Hadwin, and Mayor Pro-Tem T. Solomon for doing an amazing job at Family Fun Day. Mr. Grimes stated there were over 40 cars showed up for the first event. The president of the Mustang Club out of Savannah, GA who lives in Estill said the average for a first show is about 15 cars. Mr. Grimes stated we did an amazing job of highlighting the city of Estill and the people of Estill. Mr. Grimes stated they plan on doing it again in December, that will benefit the kids and underprivileged where everyone will bring a gift for the kids and the city will take control over distributing the gifts. Mr. Grimes also mentioned they plan to have about 100 cars. Mr. Grimes also thanks Chief Solomon and the police department for their assistance at the event. Mr. Grimes said Estill is a special place and it is not hidden anymore and there is a lot of attention being drawn to the town.

Jimmie Gordon - Directed his comments to Council. Mr. Gordon stated he lived in Newtown for about 67 years. Mr. Gordon asked about the \$1.50 fee that is on the water bill and stated it has been being paid a long time. He figures in about 1 year that is \$9,000 and he put it down for 12 years and it comes out to \$108,000. Mr. Gordon asked where those funds are being used. Mr. Gordon asked will his water bill go up 10% so if his water bill jumps from \$54 to \$74 and that will be \$10 more.

Mayor of Saluda - Directed his comments to Council. Mayor of Matthews stated he came to Estill to look at the tiny home in town. Mayor Matthews thanked Councilman A. Green and Mayor Pro-Tem T. Solomon for letting him know about the tiny home. He stated he took the trip to see what he can bring back to his community. He mentioned it is all about sharing and small municipalities must stick together. Mayor Matthews mentioned, talking to the Chief of Police about raises are coming to the police departments, they are not talking about local police they are talking about State Police. He mentioned we must make sure that we let them recognize our local police officers as first responders.

Teresa Grimes - Directed her comments to Council. Ms. Grimes stated she wanted to call attention to section 30-4-70 the freedom of information act. The freedom of information act section B states that before going into executive session the public agency shall vote on that subject matter or question in public. She said she was following up to see if we will be following the State laws in doing this and moving forward. Ms. Grimes asked if we would have better transparency with the citizens so that all of the questions we have are more transparent on the agenda and as described in the section 30-4-70.

Kendall Youmans - Directed his comments to Council. Mr. Youmans stated he is from Nixville, SC. which is about 8 miles from Estill. He mentioned he came back to Estill from California in the Marine Corp to help the Town of Estill with anything they need.
